

PETITION FOR RECALL

TO THE HONORABLE Board of Supervisors of Ventura County, Pursuant to the California Constitution and California election laws, we the undersigned registered and qualified electors of the 2nd Supervisorial District of Ventura County, California, respectfully state that we seek the recall and removal of Linda Parks, holding the office of Supervisor of the 2nd Supervisorial District of Ventura County, California. We demand an election of a successor to that office. The following Notice of Intention to Circulate Recall Petition was served on February 12, 2021 to Linda Parks:

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

TO THE HONORABLE LINDA PARKS: Pursuant to Section 11020 of the California Elections Code, the undersigned, registered, qualified voters of VENTURA COUNTY SUPERVISORIAL DISTRICT 2, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of BOARD OF SUPERVISORS, DISTRICT 2, in VENTURA COUNTY, California, and to demand election of a successor in that office.

The grounds for the recall are as follows:

County Supervisor Parks is NOT serving our neighborhoods. Her votes to sue members of our community and other actions are destroying them. Here is how. She tells us to:

- Close our schools.
- Stay away from others.
- Lockdown in our homes.
- Not visit loved ones in the hospital or nursing homes.
- Bury our dead while restricting mourners from grieving together.
- Shut down our churches and businesses (some will never open again).

Supervisor Parks never misses a paycheck. She gets a six-figure, taxpayer-funded salary while engaging in conduct harmful to the interests of the people that voted her into office. Many have lost their paychecks, jobs, businesses, homes, and loved ones. Supervisor Linda Parks:

- Denies people their due process.
- Spends taxpayer money on lawsuits, targeting a church and our small business owners.
- Relies on questionable State and County COVID Closure orders without legitimate scrutiny.
